As a swimmer for Mariemont Aquatic Club or the parent/guardian of a Mariemont Aquatic Club swimmer, I will do my part to make details of this contract a reality.

## FINANCES

I understand that I am responsible for paying all team fees in full at the beginning of the season, and that these fees are non-refundable (as stated and outlined in the Mariemont Aquatic Club Handbook). I understand that I may have to pay additional fees throughout the season with regards to my participation in meets, and I will make these payments on time.

## PRACTICE

I understand that I am responsible for arriving at swim practice 10 minutes prior to the start of my designated practice and will be ready and waiting on the pool desk with the necessary equipment. When at practice, I will give my best effort, fullest attention, and have a positive attitude at all times. In addition, I will meet the requirements for attendance for my practice group. In the event that I cannot make it to practice due to extenuating circumstances or illness, I will notify my coach before hand or as soon as possible.

## MEETS

I understand that I am responsible for arriving at all meets 15 minutes prior to warm-ups with a positive attitude and ready to put forth my best effort in competition. I will bring all necessary equipment including my team suit, cap, goggles, towels, warm clothing, etc. I will behave in an appropriate manner at all times, treating the members, fans and facilities of the other teams as well as my own with respect.

## CONDUCT

As a member of Mariemont Aquatic Club, I will remember that everything I do is a reflection of my team, its coaches and members, and that my actions either credit or discredit my team, its coaches and members at all times. Thus, I will conduct myself in a sportsmanlike manner at all times to better both myself and my team.

Failure to comply with the Mariemont Parent and Swimmer Contract may result in, but will not be limited to the following (all repercussions are subject to the discretion of the Mariemont Aquatic Club Board and Coaching Staff):

1st incident: Swimmer will be removed from practice or meet

2nd incident: Swimmer will be removed from practice or meet and parent/guardian is notified.

3rd incident: Appropriate disciplinary action is taken after review by the Coaching Staff and the MAC Board.  
This includes, but not limited to, expulsion from practice for a definite period of time or expulsion from Mariemont Aquatic Club

I acknowledge that I have received and understand the Mariemont Aquatic Club Handbook and Parent and Swimmer Contract. I understand that I am responsible for reading and understanding the information contained within these sources, and that failure to comply with all rules, regulations and responsibilities within these documents will have consequences as set forth above.
